Subject matter of the contract: provision of monitoring and media services in the following Middle Eastern countries: Jordan, the UAE, Saudi Arabia, Morocco, Algeria, Bahrein, Qatar, Oman, Sudan.

The public notice about request for proposals and procurement documentation were published on «2» of February 2024 on the Internet on the official website <http://zakupki.rosatom.ru/> (№240202/5534/004), on the regional website <http://rosatom-mena.com/>.

The terms of the contract are determined by combining the original contract draft given in the request for proposals, and the bid of the Sole Admitted Participant of the request for proposals, including the content and scope of services, terms of service, taking into account these Pre-Contractual Negotiations.

The contract price of the Sole Admitted Participant of the public request for proposals is 280,080.00 AED, not subject to VAT.

The pre-contractual negotiations are being held via audio call at 14.00 (local time) on «11» of March, 2024 at the address: Office 1108A, Business Central Towers, DIC, Dubai, UAE, P/O 500705.

Pre-contractual negotiations are conducted in accordance with subparagraph a) of paragraph 2, article 9.3 of the Rosatom Procurement Standard (Procurement Regulations) in the wording specified in the documentation on request for proposals, and paragraph 14.1 of part 2 of volume 1 of the documentation on request for proposals.

As a result of the pre-contractual negotiations, the following agreement were reached:

1. The contract price is reduced and is 279,252 AED, not subject to VAT.
2. Appendix No. 2 of the contract shall be amended as at the Annex 1 to these Minutes.
