2. Based on the results of consideration of the bids at the selection stage, the procurement committee made the follow decisions:

2.1. To admit the participant Sustainable Enerji Projeler Limited Sirketi who meets the requirements established by the procurement documentation and who submitted the bid that meets the requirements established by the procurement documentation, to further participation in the request for proposals.

2.2. To deny admission to further participation in the public request for proposals to the participant Carma Media Insight on the basis of clause 6.6 of Part 3 of Annex 12 of the Rosatom Procurement Standard (Procurement Regulations) and 5.10 of Part 2 of Volume 1 of the Procurement documentation, due to the fact that the bid is not stitched in accordance with the procedure specified in clause 5.10 of Part 3 of Annex 12 of the Rosatom Procurement Standard and clause 5.10 of Part 2 of Volume 1 of the Procurement documentation.

2.3. To deny admission to further participation in the public request for proposals to the participant Veer Intelligence Solutions on the basis of clause 6.6 of Part 3 of Annex 12 of the Rosatom Procurement Standard (Procurement Regulations) and 5.10 of Part 2 of Volume 1 of the Procurement documentation, due to the fact that the bid is not stitched in accordance with the procedure specified in clause 5.10 of Part 3 of Annex 12 of the Rosatom Procurement Standard and clause 5.10 of Part 2 of Volume 1 of the Procurement documentation.

2.4. To deny admission to further participation in the public request for proposals to the participant Conceptual Communications Events Management on the basis of clause 6.6 of Part 3 of Annex 12 of the Rosatom Procurement Standard (Procurement Regulations) and 5.10 of Part 2 of Volume 1 of the Procurement documentation, due to the fact that the bid is not stitched in accordance with the procedure specified in clause 5.10 of Part 3 of Annex 12 of the Rosatom Procurement Standard and clause 5.10 of Part 2 of Volume 1 of the Procurement documentation.

Due to the fact that the only bidder is admitted to the public request for proposals, as per sub-paragraph b) of paragraph 1.2, part 1 of article 6.4 of Procurement Regulations, the public request for proposals is recognized failed.
